Change**



WHAT IS PSE CHANGE?

Policy


Creation or alteration of a formal written statement of a government, business, or nonprofit that results in a new organization position, decision, action, or mandatory rule or regulation

System

Informal and ongoing change in organizational practices and procedures that results in a new, voluntary way of doing business


Environmental

Directly alters the physical, economic, social, or messaging environment that results in a new level of access or opportunity for the target population

Health Factors & their Contributions to Health Outcomes





Health Impact Pyramid





Let's say an employee
wants to remove
unhealthy items from the
office vending machines



Education:

The employee talks to coworkers about why they shouldn't drink sugary beverages.

Education is not a PSE change



- Requires ongoing coaching and reinforcement
- Limited impact
- No policy, system or environmental conditions have changed to encourage healthier choices



**Environmental change:
Removing the unhealthy items from the
vending machine.**

Environmental Change

Benefits

- Takes less time
- Fewer resources needed to accomplish

Considerations

- May not be self-sustaining to implement changes alone
- Changes require monitoring and maintenance



System change:
Asking the distributor to only
stock healthy items.

System Change

Benefits

- Changing organizational procedures and practices
- Impacts all elements of organization, institution, or system

Considerations

- Limits change to organization
- May affect other associated institutions



Policy change:
Rewriting your vending machine contract
to require only healthy items.

Policy Change

Benefits

- Formal
- Binding
- A general approach to be applied broadly

Considerations

- Takes substantial time and effort
- Challenging to implement, depending on scope or area of focus

Healthy Vending

Policy Rewriting your vending machine contract to require only healthy items

System Asking the distributor to only stock healthy items

Environmental Removing the unhealthy items from the vending machine


A local community organization asks retailers near schools to voluntarily remove sugary drink ads from their store windows.

Review

- PSE are pieces that can **work together**, not as isolated options to change

Provider Roles

Roles	Level of Involvement
Connector	Low
Advocate	Low
Amplifier	Medium
Team Expert	Medium
Leader	High

Connector



Identifies other providers in the community to augment support for an issue

Low commitment:

A one-time role that requires a limited commitment and is not central to the implementation or sustainability of the intervention (e.g. testifying at a public meeting)

Advocate



Advocates for a specific policy, decision, or change

Low commitment:

A one-time role that requires a limited commitment and is not central to the implementation or sustainability of the intervention (e.g. testifying at a public meeting)

Amplifier



Writes, speaks, blogs, or is interviewed about an issue

Medium commitment:

An ad-hoc role that requires a moderate time commitment and is not central to the implementation or sustainability of the intervention (e.g. attending 3 task force meetings to help design a policy)

Team Expert



Joins an existing collaboration or partnership, or provides subject matter expertise

Medium commitment:

An ad-hoc role that requires a moderate time commitment and is not central to the implementation or sustainability of the intervention (e.g. attending 3 task force meetings to help design a policy)

Leader



Identifies or produces resources, convenes stakeholders, or establishes multi-sectoral partnerships

High commitment:

Ongoing role that requires a significant time commitment and is central to the implementation or sustainability of the intervention (e.g., securing funding for, and helping to design and manage an ongoing physical activity program)



Healthy Food & Beverage Standards



Healthy Food and Beverage Standards



Adopt a municipal policy requiring food stores to place healthy items instead of unhealthy items near the checkout counter

Adopt a payment policy at a local farmers market that allows SNAP participants to purchase produce with their SNAP benefits

School Wellness



School Wellness



Change the recess schedule to increase the amount of time available for students to be physically active during the school day

Safe Routes To School



Safe Routes to School



Adopt a transit agency policy that funds free or reduced-cost bus passes for low-income students

Structured Physical Activity



Structured Physical Activity



Create a hospital-based physical activity program, offering voluntary dance and yoga classes for patients and staff on hospital grounds
