# Sabrina Adler, JD ChangeLab Solutions



As senior staff attorney & program director, Sabrina works primarily on legal and policy issues related to school foods and food marketing to children. Before joining ChangeLab Solutions, she was a staff attorney at the Child Care Law Center, where she assisted legal aid attorneys with child care cases and did policy work on health and obesity prevention in the child care setting, due process protections for parents with child care subsidies, and child care licensing standards. In addition, she received a Skadden Foundation Fellowship to found the San Francisco Medical-Legal Partnership (a collaboration between Bay Area Legal Aid and San Francisco General Hospital), in which she provided direct legal services to low-income pediatric patients and their families. Her practice included advocacy in the areas of housing, health, public benefits, disability, education, and family law. Sabrina graduated from Brown University (magna cum laude) and Stanford Law School.

## Rachel Borovina, MD Champion Provider Fellow, San Mateo County



Rachel Borovina, MD, is a primary care Pediatrician for San Mateo County Health and recently joined Hillcrest Juvenile Hall as Medical Director. She began her journey in public health as an undergraduate working with California Project LEAN, a Public Health Institute program that advances nutrition policy in schools and early childcare settings. During her pediatric residency, she trained at ZSFGH's Healthy Lifestyles Clinic. Inspired by this multi-disciplinary approach, in 2005 she founded Healthy Lifestyles Clinic-SM for San Mateo Medical Center where she continues to encourage healthy habits and connect families to community resources. During her Champion Provider Fellowship, Dr. Borovina partnered with San Mateo NEOP to create San Mateo County ParkRx. This program empowers providers to promote the benefits of nature on one's physical and mental health. SMC ParkRx integrates resources within the clinical setting and electronic medical record while facilitating a direct connection between the medical home and nature.



# Wilma Chan Alameda County Board of Supervisors, District 3



Wilma Chan is the first Asian American elected to the Alameda County Board of Supervisors and the first woman and Asian American to be Majority Leader when she served in the California State Assembly. She is President of the Board of Supervisors and Chair of the Health Committee. Supervisor Chan has been involved in several key policy initiatives, including declaring a "New War on Poverty", launching the "All In to End Hunger 2020" campaign to eliminate food insecurity in Alameda County, and leading the county to become the first in the nation to commit to connecting all eligible children to health care coverage. She has authored several groundbreaking bills, including one that implemented a no-lead standard in drinking water pipes and fixtures, another historic legislation to end the practice of hospitals overcharging un/underinsured patients and to cover California's 800,000 uninsured children. Ms. Chan wrote the strategic plan to keep the Alameda County Medical Center open, formed the Alameda County First Five Commission, implemented a citizenship program with the passage of welfare reform, and established youth collaboratives in Alameda and San Leandro focused on improving the lives of young people. Ms. Chan has served on the Oakland Board of Education, California Medical Assistance Commission, as the Legislator-in-Residence and Political Science teacher at UC Berkeley and as Vice President for Policy at Children Now, a national children's advocacy organization. Awards include Person of the Year, Legislator of the Year, Outstanding Public Service Award, and many more.

Jessica Davidman, MPH, is the Administrative Coordinator for the Champion Provider Fellowship. ## Alicia Fernández, MD

Dr. Fernández is a Professor of Clinical Medicine at UCSF and an attending physician at ZSFG. Her research focuses on health and health care disparities, and she is particularly interested in diabetes, Latino health, immigrant health, and language barriers. In addition to her research and clinical practice at ZSFG, Dr. Fernández is an active mentor of students, residents, fellows, and faculty. She has received several honors and awards, including the Arnold P. Gold Professorship for Humanism in Medicine. She has served as an advisor to the Robert Wood Johnson Foundation, the California Endowment, the National Quality Forum, the Commonwealth Fund, the American Medical Association, the American Board of Internal Medicine, and other organizations focused on health care disparities, Latino health, and limited English proficiency populations. Dr. Fernández was a standing member of the Agency for Healthcare Research and Quality (AHRQ) Health Care Quality and Effectiveness study section (2006-2010), and is currently a member of NIH Health Services Organization and Delivery (HSOD) study section. Dr. Fernández was recently appointed to the Board of Governors of the Patient-Centered Outcomes Research Institute (PCORI) and the Institute of Medicine Roundtable on Literacy.

After majoring in Political Science at UC Berkeley, he earned a MPH with a dental emphasis, and a Juris Doctorate with a healthcare focus while he attended dental school at UCSF. During dental school, he received two research fellowships and his research topics have included dentin remineralization and oral health needs assessments of individuals with developmental disabilities. He was Chief Resident for Community Medical Centers and the Fresno VA's general practice residency. Dr. Hsiao was past faculty at UCSF's AEGD clinic. As part of the American Dental Association's Institute of Diversity in Leadership program, Dr. Hsiao developed a project called "Good Oral Hygiene: even a 5-8 year old can do it!", which can be viewed on YouTube. In 2017, he received the ADA's David Whiston leadership award. He just finished his term as President of the Fresno Madera Dental Society and is also serving his third year on the California Dental Association's appointed Judicial Council position. He currently owns two small private offices in Fresno county serving a large population of Denti-Cal patients, veterans, and private patients. During his spare time, he mentors high school and junior high school students at UCSF's Doctors Academy and is the dental advisor for Fresno County's Local Dental Pilot Project (also known as the Statewide Dental Transformation Initiative (DTI)). In Fresno, He cofounded Veterans Smile Day three years ago and last year they saw 70 plus patients and provided approximately \$100,000 in dental treatment. In the past, he's worked for a mobile dental clinic, private offices, and a community clinic around the Fresno area.

Asbury is the Public Relations Manager with Nutrition Education Obesity Prevention Branch at the California Department of Public Health. Dr. Kurtz received both her undergraduate and graduate degrees in Nutrition at the University of California, Davis, where she currently still teaches a Nutritional Anthropology course, coordinates MPH seminar courses, and serves as a faculty advisor to MPH students.

Named one of the *Top 20 People Making a Difference In Healthcare In America*, "San Francisco Super Doctor," and recipient of the *Perlman Award for Medical Journalism* and an *Award of Excellence in State Advocacy*, Dr. Maa is the Chief of the Division of General and Acute Care Surgery at Marin General Hospital. He is an Army Veteran and UC Berkeley and Harvard Medical School graduate. He undertook a public policy sabbatical in Washington DC where he worked with members of congress, Capital Hill, and the media including CNN, CSPAN, the New York Times, and the Wall Street Journal. In 2012, Dr. Maa was the first requestor of an election recount of a statewide ballot measure in the history of the State of California. He has been involved in each of the subsequent statewide California ballot recounts, and has assisted with National election integrity efforts. In 2018, he served as the San Francisco Marin Medical Society President.

Based at the Zuckerberg San Francisco General Hospital campus, Alana is the Project Manager for the Champion Provider Fellowship. Alana's area of focus has been obesity prevention and community engagement. She has worked in the Los Angeles area for the American Diabetes Association and the LA Junior Chamber of Commerce, where she managed the LA Watts Summer Games, interfacing with key leaders and stakeholders from multiple sectors. ## Dean Schillinger, MD

Dean Schillinger, MD is UCSF Professor of Medicine in Residence and a primary care physician at San Francisco General Hospital (SFGH). He serves as Chief of the UCSF Division of General Internal Medicine at SFGH and directs the Health Communications Research Program in the UCSF Center for Vulnerable Populations. Dr. Schillinger served as Chief Medical Officer for the Diabetes Prevention and Control Program for California from 2008-13. He was honored with the 2003 Institute for Healthcare Advancement Research Award, the 2008 Research Award in Safety and Quality from the National Patient Safety Foundation and the Bay Area Research Mentor of the Year Award in 2010 and the 2016 Institute for Health Policy Career Mentoring Award. In 2013, he received the Everett M Rogers Award from APHA in recognition of his lifelong contributions to advancing the study and practice of public health communication. He co-created a youth-led diabetes prevention social media campaign called The Bigger Picture Campaign, which received the 2014 Latino Coalition for a Health California Award for Youth Leadership and the Spirit of 1848 Social Justice Award from the American Public Health Association (APHA). Dr. Schillinger has been instrumental in local public health regulation of sugary drinks, and served as the scientific expert for the City and County of San Francisco in defense of a lawsuit filed in Federal Court by the American Beverage Association for an injunction against the City's ordinance to mandate health warning labels on billboards advertising sugary drinks.



### Hilary Seligman, MD, MAS

### UCSF Division of General Internal Medicine/Zuckerberg San Francisco General Hospital



Hilary Seligman, MD, MAS has appointments in the Departments of Medicine and of Epidemiology and Biostatistics. She directs the Food Policy, Health, and Hunger Research Program at UCSF's Center for Vulnerable Populations and the CDC's Nutrition and Obesity Policy, Research and Evaluation Network (NOPREN). She also serves as Senior Medical Advisor for Feeding America. Dr. Seligman's research focuses on food insecurity and its health implications across the life course. She has published more than 50 papers on the topic, including in such journals as New England Journal of Medicine, Health Affairs, and American Journal of Public Health. Her policy and advocacy expertise focus on federal nutrition programs (particularly SNAP), food banking and the charitable feeding network, hunger, food affordability and access, and income-related drivers of food choice. Dr. Seligman founded Vouchers4Veggies, a healthy foods voucher program for low-income residents of San Francisco. She also serves on the Food Security Task Force for the City and County of San Francisco. She completed her undergraduate studies at Williams College, medical school at Baylor College of Medicine, and residency and post-graduate training at University of California San Francisco. She is a Fellow of the American College of Physicians.

### Wagahta Semere, MD, MHS

Dr. Semere is an Assistant Clinical Professor at UCSF and primary care physician at Zuckerberg San Francisco General Hospital. She recently completed a fellowship in health services research with the Robert Wood Johnson Foundation Clinical Scholars Program at Yale. Her research focuses on understanding the health and health care needs of vulnerable populations, with a particular interest in language and communication barriers. She has extensive experience working with diverse immigrant and refugee communities. As a fellow, she was trained in and applied methods of Community-based Participatory Research (CBPR) in her work.

## Vivi Stafford, MD, MPA

Dr. Stafford has a BA in Anthropology from the University of Southern California, and obtained her medical degree from the University of Minnesota in 1999. She did her general surgery internship at Mount Sinai Medical Center in New York, where she was on trauma call during the events of 9/11. Dr. Stafford is in the process of earning a Master's in Public Administration from USC. As a primary care and addiction medicine physician, Dr. Stafford wants to apply her intersectional knowledge of healthcare, public policy, and the legal system in curbing the rise of chronic disease. As a Champion Fellow based out of Lemoore (an agricultural community where nearly one in five people live in poverty), she will work with Central Valley communities to ensure increased access to primary care, and to campaign for preventative healthcare policies.



### Vanessa Thompson, MD

Dr. Thompson is an Associate Clinical Professor at UCSF and a primary care physician at Zuckerberg San Francisco General (ZSFG). She also serves as the Associate Medical Director for the Richard Fine People's Clinic at ZSFG. Her expertise is in medical education and care for underserved populations. Dr. Thompson is the Principal Investigator for the Champion Provider Fellowship Initiative, where her responsibilities include supervising the project coordinators, and working closely with UCSF faculty and collaborators on program development.

## Scott Wiener California State Senate, District 11



Senator Scott Wiener represents San Francisco and northern San Mateo County in the California State Senate. Elected in 2016, Senator Wiener focuses extensively on housing, transportation, civil rights, criminal justice reform, clean energy, and alleviating poverty. He chairs the Senate Housing Committee. Before being elected to the Senate, Senator Wiener served as a member of the San Francisco Board of Supervisors, representing the district previously represented by Harvey Milk, and chaired the San Francisco County Transportation Authority. Before being elected to office, Senator Wiener practiced law for 15 years, including nearly a decade as a Deputy City Attorney in the San Francisco City Attorney's Office. He also served in a number of community leadership roles, including co-chair of the San Francisco LGBT Community Center and on the national Board of Directors of the Human Rights Campaign. Senator Wiener has lived in San Francisco's Castro neighborhood since 1997. He received degrees from Duke University and Harvard Law School.
